FORDISCLOSURESPURSUANTTOREG.300FTHESEBI(LISTINGOBLIGATIONSANDDISCLOS UREREQUIREMENTS)REGULATIONS,2015

1. <u>INTRODUCTION</u>

The Securities and Exchange Board of India (SEBI) has notified the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations, 2015") which shall be applicable to all listed entity) on September 2, 2015 to be effective from November 9, 2015.

Regulation 30(8) of the ListingRegulations, 2015 is re-produced as under: Disclosure of events or information.

Thelistedentityshalldiscloseonitswebsiteallsucheventsorinformationwhichhasbeendisclosed to stock exchange(s) under this regulation, and such disclosures shall be hosted on thewebsiteofthelisted entity for a minimum periodof five years and thereafter as per the archivalpolicy ofthelistedentity, as disclosed onits website.

2. OBJECTIVE

The objective of this policy is to prescribe a policy for archival of disclosures of events or information which has been disclosed to the stock exchange(s) under Regulation 30 of the Listing Regulations, 2015 and hosted on the website of the Company.

3. APPLICABILITYANDEFFECTIVEDATE

ThisPolicyshallbeapplicabletotheCompanywitheffectfrom9thNovember, 2015.

4. <u>DEFINITIONS:</u>

- "Act" shall mean the Companies Act, 2013 and the rules framed the reunder, including any modifications, clarifications, circulars or re-enactment thereof.
- **"BoardofDirectors"**or**"theBoard**"meanstheBoardofDirectorsofVandana Knitwear Limited,asconstitutedfromtimetotime.
- "ListingRegulations" means the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015.
- "Policy" means the Archival Policy of the Company.
- "MaterialEvents" means events as specified in Schedule III to the Listing Regulations from time to time upon occurrence of which the Company shall make disclosures to stock exchange as perthe 'Policy for Determination of Materiality of Event/Information of the Company.
- **"Stock Exchange"** means the Bombay Stock Exchange Limited ("BSE") and National StockExchange("NSE")and any otherexchangewhereshares of the Company are admitted forlisting.

AnyothertermnotdefinedhereinshallhavethesamemeaningasdefinedintheAct,ListingRegulationsorany otherapplicablelaworregulationtotheextentapplicabletothe Company.

5. ARCHIVINGOFDOCUMENTSWHICHAREHOSTEDONCOMPANY'SWEBSITE:

- A. All Documents generated, disclosed by the Company, on its website, for the purpose ofshareholdercommunication, are the properties of the Companyincluding archival material.
- $B. \ \ Archival material of the Company shall not be destroyed or purged without the approval of the head of the department to which such archival material belongs.$

Provided that nothing contained here in shall be deemed to lead to an exception exception exception case of an accidental deletion, or deletion due to any system flaw, virus, or any other deletion, in accessibility or loss due to any reason other than deliberate and determinate deletion.

C. Archival materialsoselected forpreservationshallbesentto the Company archives inconsultation with the head of concerned department, which there after may be removed asper the schedule provided herein.

6. ARICHIVALREQUIREMENT:

- (1) The disclosures made to stock exchange under regulation 30 would be uploaded on the website of the Company.
- (2) The disclosure of material events shall be hosted on the Company's website for a minimum period of 5 (five) years from the date of posting.
- (3) Thereafter, the information would be archived under the heading "PastEvents/Information" and would be retained on the website for a period of 1 (One) year.

7. PROCEDURE:

The Company Secretary of the Company shall arrange for uploading on the website of the Company all the disclosures made by the Company in pursuance to the Regulation 30 of the Listing regulations as soon as possible.

AllsucheventsorinformationsodisclosedonthewebsiteoftheCompanyinpursuancetoRegulation30oftheListingRegulations,2015shallbearchivedaftertheexpiryofthefiveyearsfrom the date of such posting and moved to the location or place under - "Historic Material Events /Information".

Theevents/informationsoarchivedunder "Historic Material Events/Information" shall be preserved for a further period of three years or till the time such events or information are resolved or closed, which everislater.

In addition to maintaining the records on the website, the Company shall also maintain the physicalcopies of such disclosure made to the stock exchanges(s) which shall be preserved for the period asper the Company's Policy on Preservation of Documents.

8. <u>AMENDMENTANDREVIEWOFTHEPOLICY</u>:

In case of there are any regulatory changes requiring modifications to the policy, the same shallbereviewed and amended with the approval of the Board of Directors. However, the amendment in the regulatory requirements shall be binding even if not incorporated in this Policy.
